



JUNGLEQUEST ASSUMPTION OF RISK/WAIVER/RELEASE OF LIABILITY

Participant understands and agrees that risks and dangers of injury to person or property or of death exist and are inherent in the activities taking place at Jungle Quest. These activities include but are not limited to climbing, mountaineering, bouldering, rope courses, zip lines, slides, and other entertainment and sport-related activities. Participant is fully capable of engaging in all of the activities at Jungle Quest and assumes the risk of any and all injury, death, damage, loss, and property damage or loss that is associated with, caused by, or results from the activities taking place at Jungle Quest.

Participant agrees that he or she shall obey all instructions, signs, and directives while participating in the activities at Jungle Quest. Participant further agrees that he or she shall exercise the highest degree of care that a reasonably careful person could and would exercise while participating in the activities at Jungle Quest. Participant permits photographs to be taken if used for publicity purposes.

In consideration for being permitted to participate in the activities at Jungle Quest, Participant waives any and all claims and causes of action arising from the activities taking place at Jungle Quest and further releases Jungle Quest from any and all legal liability arising from such activities. This waiver and release includes but is not limited to any and all claims, causes of action, and liability for carelessness, negligence, gross negligence, recklessness, willful and wanton conduct, breach of warranty, and breach of contract.

Participant authorizes Jungle Quest to call for medical care on the premises or for transportation to a medical facility if Jungle Quest reasonably believes that medical attention is needed for Participant. Participant agrees to pay any and all costs associated with such medical care and transportation.
